- A **Service Agreement** pack (branded to your business - if you provide us with your logo and contact details)
- A written **training policy** and related procedures. Should no staff be employed this should demonstrate the license holders own knowledge development. This must also cover dog welfare, dog handling, dog behaviour, cleanliness and hygiene, feeding and food prep, disease control, recognising and treating sick animals)
- A **cleaning and disinfecting** procedure (to include isolation provisions)
- A procedure covering **transportation**
- A procedure covering **feeding**
- A procedure covering the **prevention of, and control of the spread of, disease**
- A procedure covering the **death or escape of an animal**
- A procedure covering the care of animals following **suspension/revocation of the licence** or during and following an emergency (**emergency plan**)
- A **fire risk assessment and documented fire procedure** required
- A **documented trial familiarisation** session for all dogs prior to stay
- A daily **health and behaviour record** for each dog
- A letter to your veterinary practice that (on signature) meets your obligations regarding a **preventative healthcare plan** agreed
- A procedure to accommodate the needs of **dogs under one year of age**
- A policy for **monitoring new dogs** coming into the home boarding environment
- If resident cats are present at the property a procedure to identify stressors and how these would be mitigated needs to be in place (not provided)
- If **children under the age of 16** reside or visit the premises a suitable written procedure must be in place to safeguard the children and the dogs
- A **record form of all euthanasia**
